



# 2 Enrollment


- 2. Log in to the APP Store, download and install the App.



# 6 Formatting

Remove the battery. Hold any button for 8 seconds and meanwhile put the battery in . The red LED flashes 3 times when the formatting is completed.

# 7 Set up with App

You can view the device status including temperature, signal intensity, battery level, connection, 24-hour zone, and operation mode on the device page. Tap the obtton to enter the settings page.

Function	Description
Zone Type	Select the zone type of the detector.

Cross Zone	If the alarm triggered in both of the linked zones within the set time, two alarm messages will be reported.

Polling Rate	Set the interval of heartbeat.
